1. Dogs participating in In Board Training must have all required **vaccinations** or proof of protective titers for the following: Rabies, DHPP (Distemper, Hepatitis, Parainfluenza, and Parvovirus) and Kennel Cough (Bordetella). Vaccination against Canine Influenza is strongly recommended. A copy of proof of vaccinations or titers must be presented before In Board Training begins. Dogs must also be on **a heartworm preventative** and **a flea and tick preventative** and the owner must provide these medications for the dogs if they will be required during the course of in-board training.
  
2. **In Board Training tuition is due in full *before* the stay begins.** Availability in Teamworks Dog Training In Board Training is limited, and will offered on a first paid, first served basis. **Reservations are made online or by calling the office at 919-855-0422,**
  
3. The tuition for In Board Training at the **Raleigh** location is:
  - **\$1400** for 30 days of InBoard training package (2 training sessions / day & one play session / day)
  - **\$65** per night for High Energy Board and Train (2 training sessions/day & one play session/day)
  - **\$55** per night for Manners Maintenance Board and Train (1 training session/day & one play session/day)
  - **\$45** per night for Stay & Play (1 play session per day)

**\* Please note: There is a \$5 holiday surcharge per night for the week surrounding major holidays. During these time periods, extra staff is brought in to help with the larger number of dogs.**
  
4. The tuition for boarding at the **Youngsville** location is:
  - **\$40** per night for boarding

**\*Please note: Training sessions and group play sessions are not available at the Youngsville location**

5. Discounts are as follows:
  - **\$5 per night discount off High Energy Board and Train rate for more than one dog per household**
  - **\$5 per night discount off High Energy Board and Train rate for a stay of 7-29 consecutive days**
  - \* **Please note: these discounts and any other discounts cannot be combined**
  
6. **\*Each month package** of In Board Training will include a total of **60 personalized one-on-one training** sessions with a Teamworks Instructor, one play session each day with an appropriate canine playmate or with a training assistant, **and baths/grooming sessions as needed\***, One-month training will also include a Gentle Leader or Easy Walk Harness, if needed. **A FREE GROUP CLASS will be included as a follow up session** with the owner after the dog arrives back home (to be arranged by the owner). The owner may be given a **published training book(s)**, if applicable, instead of a follow-up class (for owners who opt for training books or who live more than one hour away from Teamworks). Training goals are set by the owners using the *In Board Training Profile Form*. Training sessions will be customized to the dog's attention span and interest level.
  
7. **Each day of High Energy Board and Train will include 2 training sessions per day.** Training goals are set by the owners using the *In Board Training Profile Form*. Trainers will devise an individual training plan for each dog based on the owner's goals. Training sessions will be customized to the dog's attention span and interest level. Long-term training goals will not be achievable in short refresher periods, but rather, behaviors that have been previously taught will be reviewed with the dog.
  
8. In Board Training also includes care and feeding, **24/7/365** caretakers, regular exercise and play, treats, and interactive toys for the dog. In Board Training will include a rotation of different Teamworks trainers, for diversity in training experience and so that the dog is able to generalize the training to more than one person.
  
9. In Board dogs will live inside, in their own assigned rooms at the Raleigh location, and in their own assigned crates at the Youngsville location. **For this reason, absolutely no outdoor-only dogs will be accepted into the In Board program, and dogs must be crate-trained prior to beginning in-board training.**
  
10. Each day the dog's owner will receive a video in a DropBox folder with highlights from the week's training sessions. Owners should review the weekly videos and written reports and to provide the trainer with feedback by email. Updates will also be posted on our training blog at: <https://teamworksdogtraining.wordpress.com/>
  
11. Dogs boarding at the Youngsville location will live in the owner's house and get 3-5 hours of outside playtime a day, weather permitting. Dogs will only be grouped with compatible dogs from the same household.

**12. Owners are asked to bring:**

- A supply of the dog's regular food in a Zip-Lock bag. PLEASE NOTE: If the owner fails to provide enough food for the dog's stay, we will give the dog ProPlan Sensitive Skin & Stomach Salmon and Rice diet at a charge of \$5 per day.
- Any medications the dog needs to take: PLEASE NOTE: ANY MEDICATIONS MUST BE PUT INTO A PILL MINDER FOR YOUR DOG, WITH THE DOSAGES AND MEDICATIONS CLEARLY WRITTEN ON THE PROFILE FORM. If the owner fails to provide a pill minder for the dog's medications, one will be provided at check-in and the owner must take the time to put the pills into the pill minder before leaving the dog.
- The dog's favorite treats
  - The dog's favorite chewables (like bully sticks)
  - Heartworm preventative and flea & tick preventative medications
  - A well-fitting leather or nylon collar with identification tags
  - A leash suitable for training (a 4' to 6' leash – **not** a Flexi leash)
  - A Gentle Leader or Easy Walk Harness, if the dog already has one
  - A bag containing the dog's belongings

**13. Teamworks will provide:**

- (Youngsville location) A crate suitable for the dog's size and a private outdoor fenced area for play and exercise. PLEASE NOTE: If your dog does not go willingly into a crate, you need to select the Raleigh location. Any dog who does not go willingly into a crate in Youngsville will be moved to the Raleigh location.
- (Raleigh location) A private room for the dog that does not allow visibility with neighboring dogs or dogs walking by, but has an open top. Rotating time in an outdoor fenced area for play and exercise
- (both locations) Stainless steel feeding and water dishes
- A Gentle Leader training collar or Easy-Walk Harness (One-month package only)
- (Raleigh location) Videos of taped clips of training sessions
- (Raleigh location) Daily online blog reports
- (Raleigh location) A raised cot for dogs in Raleigh. PLEASE NOTE: IF YOUR DOG CHEWS THE COT, YOU WILL BE CHARGED \$25. If your dog does damage to any of the equipment in Youngsville or Raleigh, you will be charged a damage fee to repair / replace the damaged items.

**14. Refund / Credit Policy:**

- Dogs in heat or dogs that are ill will not be able to attend In Board Training. Credits for training will be issued on a case by case basis.
- Refunds will only be given in the case that the trainer is unable to complete the minimum number of training sessions.
- Pre-paid sessions including discounts which are not completed will be re-calculated at the non-discounted, daily rate.
- There is no guarantee that any dog will complete the training goals that are set by the owner. The results depend on the amount of "un-training" that needs to be done, the dog's genetics, the dog's personality, the dog's early socialization experience, and the dog's previous training and behavioral history. Owners will get to view videos and read about training sessions each day for the dog. We DO guarantee that your dog will be treated humanely and trained with kindness, gentleness, and patience.

**12. Visits**

- Dogs in the one-month program need to stay with the trainer for one continuous month for the best results. Owners may elect to visit their dog. Any visits need to be pre-arranged with a trainer at Teamworks Raleigh by calling for an appointment at 919-855-0422 or by emailing [teamworkshelp@gmail.com](mailto:teamworkshelp@gmail.com)

**13. Follow-Up Training**

- Owners booking a one-month training package will be given a 7-week group class as a follow-up. This can be arranged by calling 919-855-0422. The follow up group class is included in a one-month training package.
- It takes dogs some time to re-acclimate to their environment and some time to settle down emotionally from the absence. Owners should expect to give their dogs time to greet the family before beginning training.
- The owner will be expected to continue to train the dog in the same manner than was demonstrated on the videos. Dogs will need to be rewarded for good behaviors, just like in the in-board training sessions, but the frequency of and type of reward can be varied, as will be detailed in the first week's training notes. If a Gentle Leader is used in the training program, the owner will be expected to continue using the Gentle Leader.

**RELEASE AND HOLD HARMLESS AGREEMENT**

That for and in consideration of the services rendered by Greg Godlevski & Michele Godlevski, the undersigned does hereby waive and release Greg Godlevski & Michele Godlevski and Teamworks Dog Training, llc, for any loss, damage or injury to any dog, persons, or property that may occur from any cause as a result of taking part in this behavioral training activity. I recognize that there may be an element of risk in dog behavioral training/handling. I understand that as the owner of the In-Board dog, that I am responsible and legally liable for my dog's actions for the life of the dog, including the time period after in-board training. I understand that the success of any behavior training program is dependent upon numerous factors including but not limited to: the amount of time I spend working with my dog, how thorough I am in implementing the training protocol, the previous history and experience of my dog, how the dog's environment is managed, and the genetics and structure of my dog. I understand that the training my dog receives does not guarantee the dog's behavior in the future, and that dog behavior is affected by the training that I implement, the dog's previous training history, the dog's temperament, and the dog's developmental stages and the dog's environment. I understand that there are no refunds for InBoard training, due to the amount of time dedicated, the number of paid trainers, and very small and limited space of the program. I understand that treat/reward based training will be used with my dog and that I will be expected to continue training with my dog after the in-board training session in the same manners as will be demonstrated on the DVDs. I understand that a Gentle Leader may be used with my dog during training and that I will be expected to continue using it for the best results. I also understand that the trainers will NOT use choke, prong, or shock collars in the training program, even if they have been used on my dog in the past. I authorize Greg Godlevski & Michele Godlevski to take my dog to the veterinarian for any emergency. I will pay for all veterinary bills related to my dog, or any bills of another dog that my dog harms. I will pay for any damage the dog does to the owner's property or equipment. I hereby waive and release Greg Godlevski & Michele Godlevski and Teamworks Dog Training, llc from any injury or damage resulting from the action of my dog and I expressly assume the risk of any such damage or injury during or following the In-Board Training period. I hereby agree to indemnify and hold harmless release Greg Godlevski & Michele Godlevski and Teamworks Dog Training, llc from any and all claims by any member of my family or any other person accompanying me to Teamworks Dog Training, as a result of the action of any dog, including my own. I authorize Michele Godlevski to assign a Teamworks instructor to work with and care for my dog under her direction. I certify that my dog does not jump fences and has never jumped a fence and escaped the yard. I hereby waive and release Greg Godlevski & Michele Godlevski and Teamworks Dog Training, llc from any injury or damage to my dog as the result of my dog escaping from the premises. **\*\*Long-coated dogs only: I authorize Michele Godlevski to bring my dog to a groomer for a professional groom before my dog returns home at my additional expense.** I hereby authorize the employees of Teamworks Dog Training to transport my dog for a "field trip". I hereby waive and release Teamworks Dog Training, its officers, employees, owners, members, and agents from any injury or damage resulting from the act of taking the dog on the field trip. I will pick up my dog on the agreed upon date. I realize that if I do not pick up my dog after 7 days, that I will be held liable for an additional boarding fee of \$50 per day. If I do not pick up my dog after 14 days, I will relinquish ownership of the dog and Greg Godlevski & Michele Godlevski will be allowed to place the dog in another home. I realize that I am still responsible for the fees for training at the rate listed in this contract.

I understand that the tuition rates are as follows and agree to pay for the total amount by the first day of the training.

**IN-BOARD RATES:**

- InBoard Manners Package Deal: \$1400 per 30 days **(RALEIGH ONLY)**
- High Energy Board & Train: \$65 per night **(RALEIGH ONLY)**
- Manner Maintenance Board & Train: \$55 per night **(RALEIGH ONLY)**
- Stay and Play \$45 per night **(RALEIGH ONLY)**
- Boarding in Youngsville \$40 per day **(YOUNGSVILLE ONLY)**

I agree to all of the terms and requirements of In-Board Training as listed in the *In-Board Training Terms and Requirements* document and I understand that In-Board Tuition does not include food, professional grooming bills, veterinary care, registration fees, or competition fees. Veterinary visits and grooming appointments can be arranged during the In-Board stay, but must be arranged and paid for by the owner, and scheduled at the convenience of the trainer.
